_____ The animal will receive annual vaccinations according to a veterinary schedule, and will be treated immediately for any illnesses or injuries that may occur. The animal will also be kept free of pests and parasites, including ticks and fleas.

_____ The animal will not be subject to abuse by myself or other persons who live or visit my home, and will be protected from other animals in my care.

_____ The animal will be kept indoors, and not allowed to run unsupervised in an outdoor environment.

_____ I hereby agree that that animal must be spayed/neutered if it has not already been altered. I agree to have the animal spayed/neutered on or before ___/___/___ and to provide documentary proof that this has been performed. I acknowledge that Dog Saver has the right to and will reclaim the animal if the spay/neuter is not performed.

_____ I understand that Dog Saver will not give a refund after a trial period of 5 days.

_____ I understand that a Dog Saver Representative may inspect my home and the animal, upon their request.

_____ I agree to inform Dog Saver within seven (7) days of any change of address and/or phone number.

_____ I hereby agree that this pet shall wear a collar or harness with identification tags at all times.

_____ I will not sell, give away or otherwise dispose of the said animal to any person(s), dealer, retailer, auction, institute or any other entity for any reason without the written permission of Dog Saver.

_____ I am fully aware of and agree to all the terms and conditions of this agreement and understand that it is binding and enforceable by law.

_____ I release Dog Saver from any and all claims and actions, whether for property damage caused by the animal or for personal injury to me, family members and other animals in my care from biting, scratching, transmittal of disease, and/or any other matter attributable to said animal.

_____ I hereby understand and agree that Dog Saver makes no representations or warranties, expressed or implied, about the above mentioned animal's temperament and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that Dog Saver further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his family.

_____ **I certify that all statements made by me on this adoption agreement are true and correct. I agree that Dog Saver has the right to confiscate the above described animal in the event that any statements made by me are found to be false, if I knowingly fail to comply with the above terms, or in any way put the animal in a situation which endangers its health and/or welfare, or if my check for the adoption fee is returned for insufficient funds.**
